


Homeless Enrollment by Type Data 2022-2023 Cross County








Homeless Enrollment by Type Data 2022-2023 Izard County






Homeless Enrollment by Type Data 2022-2023 Lee County




Homeless Enrollment by Type Data 2022-2023 Monroe County




Homeless Enrollment by Type Data 2022-2023 Randolph County




Homeless Enrollment by Type Data 2022-2023 St. Francis County




Homeless Enrollment by Type Data 2022-2023 Searcy County




Homeless Enrollment by Type Data 2022-2023 Sharp County




Homeless Enrollment by Type Data 2022-2023 Stone County




Homeless Enrollment by Type Data 2022-2023 Van Buren County




Homeless Enrollment by Type Data 2022-2023 White County




QTR 2 Student Homeless Enrollment Data 2022-2023

Key Info/Terms Regarding PIT

- Date of the PIT: 1/26/2023
- Sheltered Homelessness: Adults, Children, and Unaccompanied Children who, on the night of the of the count, are living in shelters.
- **Unsheltered Homelessness:** Individuals sleeping in a place not designed for or ordinarily used as a regular sleeping accommodation.
- **Emergency Shelter:** Any facility with the primary purpose of providing temporary shelter for the homeless in general or for specific populations of the homeless.
- Transitional Housing: Program that provides temporary housing with supportive services to individuals and families experiencing homelessness with the goal of interim stability and support to successfully move to and maintain permanent housing.

- Youth: Persons under age 25.
- Unaccompanied Youth: Any persons under age 25 who are not accompanied by a parent or guardian or any other household member age 25 or older, and who are not a parent presenting with or sleeping in the same place as his/her child(ren).
- Parenting Youth: A youth who identifies as the parent or legal guardian of one or more children who are present with or sleeping in the same place as that youth parent, where there is no person age 25 or older in the household.
- Chronically Homeless: A person who:
 - Is homeless and lives in a place not meant for human habitation, a safe haven, or in emergency shelter; and
 - Has been homeless and living or residing in a place not meant for human habitation, a safe haven, or in an emergency shelter continuously for at least 1 year or on at least four separate occasions in the last 3 years where the combined length of time homeless in those occasions is at least 12 months; and
 - Has a disability.
